1. SCOPE

This document outlines the rules for the *Missouri QSO Party*, sponsored by the Boeing Employees' Amateur Radio Society-St. Louis (BEARS-St. Louis).

2. RULES

The General Rules for All ARRL Contests will apply except as noted.

2.1. Eligibility

Any licensed radio amateur may enter.

2.2. Object

The object of the contest is to work as many stations as possible during the contest period, to provide all licensed radio amateurs outside the state of Missouri the opportunity to work Missouri counties, and to provide all licensed radio amateurs in Missouri an opportunity to work other states and countries.

2.3. Date and Time Period

The contest has two separate operating periods, typically on the first full weekend in April. For 2022, the contest is on 2-3 April.

2.4. Modes and Frequencies

CW, Digital, and phone operation on 160M, 80M, 40M, 20M, 15M, 10M, 6M, 2M, 1.25M, and 70cm. Suggested frequencies are 1.820 MHz on 160M or 40 Hz up from the band edge on CW, and 1.880, 3.825, 7.220, 14.250, 21.380, and 28.350 MHz on SSB phone. Suggested frequencies on VHF/UHF are the standard VHF calling frequencies.

2.5. Entry Classifications

2.5.1. Missouri Fixed Stations

Missouri Fixed stations will operate from a single county within the State of Missouri. Missouri Fixed stations may work any other station once per mode on each band except mobile/expedition stations may be worked once per mode on each band for each county in which the mobile/expedition station is located. Fixed stations may operate in one of the following categories:

Missouri Fixed Multi-Op – any legal power, multi/multi allowed Missouri Fixed Single-Op, High Power – over 150W, one transmitted signal Missouri Fixed Single-Op, Low Power –150W or less, one transmitted signal Missouri Fixed Single-Op, QRP – 5W or less, one transmitted signal

2.5.2. Missouri Expedition

Missouri Expedition stations will operate from a single fixed geographic location Missouri expedition stations may work any other station once per mode on each band except mobile/expedition stations may be worked once per mode on each band for each county where the other station is located.

Commercial power may be used. The station and all antennas must be temporarily erected for the contest and removed afterwards. The location may not be that of a permanent amateur station. Expedition stations may operate from one of the following categories:

Missouri Expedition Multi-Op – any legal power, multi/multi allowed

Missouri Expedition Single-Op, High Power – over 150W

Missouri Expedition Single-Op, Low Power –150W or less

Missouri Expedition Single-Op, QRP – 5W or less

Expedition stations may be located at the intersection of two or more counties. They will be allowed to make multiple QSOs with the same station, one for each of the counties in which they are located. County line operations must log these contacts as separate QSOs.

Single-op expedition operations from county lines must have a portion of the station physically located inside each county claimed. Multi-op expedition operations from county lines must have a portion of at least one station physically located inside each county claimed. All equipment (including antennas) must lie within a circle whose diameter does not exceed 300 meters (1000 feet).

2.5.3. Missouri Mobile Stations

Mobile stations will operate from at least two counties within the State of Missouri. Mobile stations may work any other station once per mode on each band from each county of operation.

Mobile stations may work other Mobile/Expedition stations once per mode on each band for each county where the other station is located. Mobile stations may operate from one of the following categories:

Missouri Mobile Unlimited – over 150W, multi/multi allowed

Missouri Mobile Multi-Op, Low Power – 150W or less.

Missouri Mobile Single-Op, Low Power, Mixed – 150W or less

Missouri Mobile Single-Op, Low Power, CW – 150W or less

Missouri Mobile Single-Op, Low Power, Phone – 150W or less

Mobile operation on county lines is permitted. County line operations must log these contacts as separate QSOs. Mobile stations that operate from county lines must have a portion of their vehicle parked in each county claimed.

When not in motion, mobile stations may erect temporary antennas to increase station effectiveness. Additional antennas may not be used extend over a county line. A portion of their vehicle must still be parked in each county claimed.

2.5.4. Non-Missouri Stations

Non-Missouri stations are from any other state in the United States (including the District of Columbia (DC), Alaska and Hawaii), or any Canadian province or territory. Non-Missouri stations may work Missouri stations once per mode on each band, and mobile stations once per mode on each band for each county in which the mobile station is located.

Non-Missouri US Single Operator High Power – Over 150W

Non-Missouri US Single Operator Low Power – 150W or less

Non-Missouri US Single Operator QRP – 5W or less

Non-Missouri Multi Operator – Any legal power, multi/multi allowed

Canada – Any legal power, multi/multi allowed

2.5.5. DX Stations

DX stations are from any entity on the ARRL DXCC Countries List excluding the United States, Canada, Alaska, and Hawaii. DX stations may work Missouri stations once per mode on each Band. DX stations may work Mobile stations once per mode on each band for each county in which the Mobile station is located.

DX stations can operate any legal power. Single op or Multi Op is allowed.

2.5.6 Missouri School Club Category

Missouri School clubs entries can be any university, college, technical, primary, or secondary school.

Only currently enrolled regular students and faculty/staff of the institution are eligible to operate a school club entry. Alumni may participate on the air with students, however it is not in the spirit of the category for alumni exclusively to use the club station. Alumni should make every effort to continue in an Elmer role to current student club members.

School clubs must operate from established stations located on campus. No portable operation from a near-by contest station is allowed. If no on campus station exists, a club may operate from a member's station or set up a portable station on campus.

2.5.7 Missouri Rookie Category

All Missouri amateurs who are 18 years old or younger, or have been licensed less than three years are eligible to enter in the rookie category in addition to the categories defined in 2.5.1, 2.5.2, 2.5.3 or 2.5.6. Rookie entries should be noted as such in the Cabrillo file header or the summary sheet.

2.5.8. Missouri Club Category

Missouri stations may specify a club affiliation with their entry. Club scores will be determined by adding the scores of all Missouri stations that specify a particular club in their entry. At least three logs must be submitted to constitute a valid club entry. A club entry form is not required.

2.6. Exchange

2.6.1. Missouri Stations

Missouri stations will provide call sign, RST, and a three letter county code as defined in Table 1.

2.6.2. Non-Missouri Stations

Non-Missouri stations will provide call sign, RST, and their US state (as defined in Table 2) or Canadian province or territory (as defined in Table 3).

2.6.3. DX Stations

DX stations will provide call sign, RST, and the designation "DX".

2.7. Miscellaneous Rules

The following miscellaneous rules will apply:

- 1. As a condition of entry, participants are bound to the provisions and intent of these rules, and bound to the decisions of the contest sponsor regarding award distribution.
- 2. The use of spotting assistance or nets (operating arrangements involving other individuals, DX-alerting nets, packet clusters, etc.) not physically located at the station is permitted. Stations may spot themselves.
- 3. Cross-band and cross-mode contacts will not be permitted.
- 4. Repeaters and gateways may not be used to complete QSOs.
- 5. Soliciting a simplex contact during the contest period is permitted. APRS or other similar means may be used for posting location, frequency, and mode but may not be used for conducting QSOs.
- 6. All call signs and exchange information will be sent, received, acknowledged, and logged correctly by each station for a complete QSO. A valid contact will be a complete QSO that is not a duplicate based on the restrictions defined in paragraph 2.5.
- 7. Missouri stations will receive one DX multiplier if at least one DX entity is worked. A maximum of one DX multiplier will be awarded even if additional DX contacts are made.
- 8. Satellite contacts are prohibited.
- 9. Mobile is a station that is self-contained and capable of legal motion (street, water, or air). Operations may be conducted while stationary or in motion.
- 10. All Missouri Mobile stations Operations where one person operates and does all driving will be scored as a Single-Op. Operations where one person operates and a 2^{nd} person drives or operates will be scored as a Multi-Op.
- 11. Missouri stations should call CQ Missouri QSO Party or CQ MOQP.
- 12. Stations calling Missouri should call CQ Missouri or CQ MO.
- 13. Any digital mode contact counts as a valid QSO for digital. You can only work the same digital station once per band. (The intent of this rule is to prevent working the same station on a band via multiple digital modes.)
- 14. Single operator stations may only have one transmitted signal at a time.
- 15. All stations should provide the opportunity to be worked by everyone involved in the contest. Stations whose operation appears to be providing QSOs or multipliers only to a specific station or stations is considered unsportsmanlike conduct and may be disqualified.
- 16. County line operations must provide proof that their station was physically located in each county claimed with their log submittal. Multiple stations claiming to operate from the same three county intersection simultaneously should be prepared to show proof that their stations met this requirement simultaneously. Lack of convincing proof may lead to QSOs from more than one county to not be counted.
- 17. County line mobile operations cannot claim multiple counties when the county line intersection is located on the centerline of a road.
- 18. County line mobile operations cannot claim both counties when county line runs down the centerline of a road.
- 19. County line mobile operations cannot claim both counties for wet county line that runs down river or stream. It is not permissible to park on bridge to operate both counties.
- 20. County line mobile operations may only claim a single county while vehicle is in motion.

- 21. It is not permissible to block any road to operate multiple counties when county line is collocated with centerline of road. A road is defined as any road that appears on USGS 7.5 minute maps or any map published by the state of Missouri.
- 22. Mobile stations may append their call sign with a suffix of "/M", "/R", "mobile", "rover", or the three letter county code.
- 23. QSOs that do not include the full MOQP exchange over the air (See Para 2.6) will not be counted in the scoring process.
- 24. MOQP participants may not submit entries in multiple categories

2.8. Special Event Stations

The BEARS-St. Louis will operate a special event station, WØMA as part of the contest. A one-time (first QSO only) 100-point bonus will be added to the total score of stations working special event station WØMA. WØMA is normally located in St. Louis County (SLC), but the station may operate portable in a different Missouri county for the QSO party.

The Raytown ARC will operate a second event station, KØGQ as part of the contest. A one-time (first QSO only) 100-point bonus will be added to the total score of stations working special event station KØGQ. KØGQ will be operated out of Jackson County (JAC)

2.9. Score

The score for a participating station will be determined by multiplying the total number of valid contact points, by the total number of multipliers worked, then adding the bonus points (if applicable).

2.9.1. Points

Points for valid contacts will be awarded in the following manner:

- 1. Valid phone contacts count one point each.
- 2. Valid CW contacts count two points each.
- 3. Valid digital contacts count two points each.
- 4. At least one valid contact with the WØMA special event station will count as a single 100-point bonus added to the total score.
- 5. At least one valid contact with special event station KØGQ will count as a single100-point bonus added to the total score.
- 6. A 100 point bonus will be awarded for successfully submitting a Cabrillo log electronically.

2.9.2. Multipliers

Multipliers will be awarded in the following manner:

- 1. The multipliers for Missouri stations are Missouri counties (115 maximum), US states (49 maximum), and Canadian provinces and territories (13 maximum) worked. An additional multiplier of the value of one will be added if at least one DX station is worked.
- 2. The multipliers for Non-Missouri and DX stations are Missouri Counties (115 maximum) worked.

2.10. Reporting and Submissions

- 2.10.1. Entries must be submitted to the contest sponsor within 30 days after the conclusion of the contest. No late entries will be accepted. A complete entry will consist of one of the following in order of preference:
 - 1. Cabrillo format (no Summary Sheet required) E-mailed or sent on CD or other digital media thru postal mail.
 - 2. Paper log entry Summary Sheet required sent to WØMA
- 2.10.2. All logs generated electronically, must be submitted electronically in Cabrillo format.
- 2.10.3. All entries must specify their entry class and power level in the Cabrillo file header or summary sheet. (Note that some logging software does not correctly populate this information. Please verify the accuracy of your Cabrillo header using a text editor before submission.)
- 2.10.4. Incomplete or illegible entries will be classified as check-logs. Non-Cabrillo entries without a summary sheet will be scored as check-logs.
- 2.10.5. An example of the official summary sheet is supplied in Appendix A or it can be downloaded from the BEARS-St. Louis web site at http://www.w0ma.org. The log of contacts must show call sign, date, time, band, mode, and full exchange for each QSO.

- 2.10.7. Official results will be published on the BEARS-St. Louis web site approximately 90 days after entry submittal deadline.

- Non-Missouri US Single Operator, High Power
- Non-Missouri US Single Operator, Low Power
- Non-Missouri US Single Operator, QRP
- DX
- Missouri Rookie

- Missouri School club
- Highest Digital score
- Highest Number of Counties

In the event a plaque does not get sponsored. or the minimum QSO count is not met, the first place score will still be awarded a certificate.

Additional certificates may be awarded at the discretion of the contest sponsor.

3.2. Bonus Missouri QSO Party Certificates

Awarded to stations who spell "Show Me" or "Missouri" using the suffixes of selected 1x1 calls listed below. For letters that occur more than once, the 1x1 stations may be reused if worked on additional bands or modes Special Event Stations WØMA and KØGQ count as a wild cards and may be used in place of one missing letter.

Example: nØS wØH kØO nØW kØM nØE

The following 1x1 call signs count towards the bonus Awards: KØE, KØH, KØI, KØM, KØO, KØR, KØS, KØU, KØW, NØE, NØH, NØI, NØM, NØO, NØR, NØS, NØU NØW, WØE, WØH, WØI, WØM, WØO, WØR, WØS, WØU, and WØW.

All bonus certificate winners will be notified via email that their certificate is available to be downloaded from www.w0ma.org

3.3. Tie-Breakers

Should more than one station attain the same score, the station with the most Missouri counties worked will be awarded the higher position. The highest number of MO counties plaques and certificates will be awarded to the station with the earliest QSO time of their last county worked.

3.4. Digital awards

The digital mode plaque and certificates will be awarded to stations with the most digital QSOs multiplied by the most multipliers worked digitally. Entries do not have to be digital only entries and logs may also include non-digital contacts.

3.5. VHF awards

The VHF certificates will be awarded to stations with the most VHF QSOs multiplied by the most multipliers worked on VHF. Entries do not have to be VHF only entries and logs may also include non-VHF contacts.
